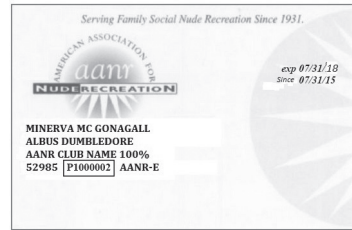

I was a former board member of the Florida region until October 2012. During that time I was Co-Chair of PR and Finance.

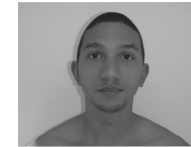
