MOTION 1:

Move to amend the following articles in the AANR-East Articles of Incorporation by adding as underlined.

ARTICLE IX.

The Bylaws may be changed, altered or rescinded as proposed by a member of the Board of Directors and approved by a vote of two-thirds (2/3) of the accredited delegates to the Regional Assembly and ratified by two-thirds (2/3) vote of the votes cast by the membership. Changes may also be proposed by petition containing the signatures of at least two hundred (200) members and passed by a two-thirds (2/3) vote of the votes cast in a mail ballot referendum and/or electronic ballot referendum.

AND

ARTICLE X.

Changes, alterations or modifications in the Articles of Incorporation may be proposed by a member of the Board of Directors and approved by a vote of two-thirds (2/3) of the accredited delegates to the Regional Assembly and ratified by two-thirds (2/3) of the votes cast by the membership. Changes may also be proposed by petition containing the signatures of at least two hundred (200) members and passed by a two-thirds (2/3) vote of the votes cast in a mail ballot referendum and/or electronic ballot referendum.

To allow for electronic voting in AANR-East.
