MOTION 4: Moved by the Legislation to amend section 9.04.01 of the Procedure Manual as follows:

All requests for reimbursements shall be sent to the AANR-East Office within 90 days of the event that the reimbursement request is for. If the event exceeds the 90-day window of the current fiscal year, requests must be made no later than December 31st of the current fiscal year. by December 15 of the fiscal year in which the expense occurred (except for any expenses incurred between December 1 and 31 of that year).

PURPOSE: To set a reasonable time limit for reimbursement requests that does exceed the 90-day limit or extend into the following fiscal year.

MOTION 5: Moved by the Legislation Committee to replace the word "associate and/or associates" anywhere they appear in the AANR-East Ruling Documents, including the Articles of Incorporation, Bylaws, Procedure Manual and the Appendix, and replace it with Direct and/or Directs.

PURPOSE: Housekeeping - to comply with the change that the AANR membership had voted on and approved in the AANR 2022 ballot.

Nominations team member Charlie stood on his written report. He had also spoken to the 3 incumbent directors if they will be rerunning.

Advocacy and Alliances team leaders Judy Turner and Shaun Card stood on their written report.

Brand team leaders stood on their written report plus under **Membership** Melody discussed what they are going to do with Survey Monkey and that a short 10 question survey will be sent out to all AANR-East members. There will be a follow-up survey later in the year.

Finance team leader Sandra Cordell did not have a written report but the budget was discussed earlier.

Linkage team leader Mary Fleck stood on her written report and thanked everyone on the **Liaison** committee for their work in contacting their respective clubs.
