PRESIDENT'S REPORT Robert Roche

For our Mid-Winter Board Meeting held at White Tail Resort on January 24th and 25th, all Officers, most Directors and our Secretary were able to meet in person. We were also joined by our AANR-East Regional Trustee, Sandra Cordell. The group was focused, open to new ideas, and there was a powerful sense of enthusiasm for what AANR-East can be as we move forward. We were joined by members from across the region. Some were present at White Tail, while others were able to use Zoom to participate.

During the Friday sessions, KRA committees discussed and worked on their projects. After a full day of committee work, the meeting participants enjoyed a great dinner together at the Trade Winds Restaurant. Following dinner, the group headed to the social hall for an evening of camaraderie and karaoke.

On Saturday morning, there was no legislation that needed attention, therefore, the meeting consisted of a full discussion of the 2025 Budget and additional work on the KRA committee tasks. At the close of the morning session, finishing touches were put on committee assignments and due dates were set.

The Interim Board meeting was called to order by President, Robert Roche, at 1:15 p.m. on Saturday, January 25, 2025. All Officers and Directors, were present for roll call with the exception of Lisa Marie Jackson who had resigned her position. The Board accepted the rules of the business circulated before the meeting and then filled the vacancy on the board with Liz Tharrington whose appointment was unanimous. The meeting also recognized several guests and members.

The AANR-East board members discussed their interim reports and various assignments. Mary Fleck announced that the summer meeting will be held at Pine Tree from June 23-26, 2025, with travel dates on June 22 and 27. The interim board meeting will take place at Whitet Tail from January 23-25, 2026, with travel dates on January 22 and 25. The Board also noted that terms for Leo Blake and Charlie Bliss will be expiring, and that Judy Turner has reached her term limit.

A bylaw change proposal was made to allow the newly elected President and Vice President to serve for three consecutive years, with a limit of six years in total. The change was clarified to apply to the newly elected officials, not those currently in office. The proposal was met with approval, with one member expressing a preference for the terms to remain at two years. The change will be put to a vote by the membership in June.

The first proposal, which aimed to allow roving ambassadors to use on-site accommodations without their own RV, was voted down. The second proposal, which was about accepting the proposed 2025 budget, was passed. The discussion also touched on the need for a new proposal regarding liaison reimbursement for travel to their assigned clubs. The conversation ended with the understanding that the roles of roving ambassadors and liaisons would be discussed in more detail in future meetings.

It was reported that only 11 clubs had responded to the background check survey. Issues were also discussed with the website. Shaun Card reported a growth of 101 followers on Instagram and 4,000 followers on Twitter. There was discussion on the need to revamp the list of club liaisons. There was also discussion of the honorary awards, lifetime achievement award, and member of the year award, emphasizing the need for proper submissions and the prestige associated with these awards. The meeting also touched on the educational grants, which are not age-restricted and require a committee of educators for the review of applications.

Saturday evening, AANR-East held its traditional wine and cheese "Meet and Greet" for the members of White Tail Resort. During this event, Bob Roche introduced each Officer and member of the Board. The Board thanked Bob for again serving as the host for their Mid-Winter Board Meeting. The evening dance began shortly after the reception and AANR-East members blended into the crowd and enjoyed the remainder of the evening.

We are now in the process of voting for three Board of Director positions via both electronic and paper ballots. The results of this election will be presented at the Regional Assembly.

Since our winter meeting I have conducted our executive (President, Vice-President, and Secretary/Treasurer) conference calls, as well as our Board Communication Calls and completed necessary paperwork related to doing business as AANR-EAST. I continue to attend the AANR Public Relations Zoom meetings to keep up with what is being done at the national level that can serve as guidance for our region.

VICE PRESIDENT'S REPORT Melody Bage

I am available to attend our executive (President, Vice-President, and Secretary/Treasurer) conference calls as needed and attend our Board Communication Calls. I serve as the history archivist for AANR-East. and the Branding committee of AANR. Reports from both areas are provided in detail in other sections of this report.

I also develop the annual ballot distributed by AANR-East.

SECRETARY/TREASURER'S REPORT Mary Fleck

As usual, the past year has been busy. Our ruling documents were updated and posted on our website. They are available for download, or a hard copy can be requested from the AANR-East office. Working with our finance team, a budget was successfully prepared and submitted to the Board for their approval.

The 2025 Delegate Credential forms have been emailed and 2 were mailed to our contract clubs for the AANR-East Regional Assembly which will be held in person and via ZOOM Wednesday, June 25, 2025. We ask that the clubs hold their elections and submit the delegate credentials to the AANR-East office as soon as possible and to be sure that their delegate has a copy at the Regional Assembly.

As always all of the submitted written reports will be available on our website. If a printed copy is desired, the delegates can request them from the office by either calling 850-640-4944 or by email at secretarytreasurer@aanr-east.com.

The Ballot had been prepared by Melody Bage and posted on our website. Thank you, Melody. We had a slate of three candidates for three positions for the membership to consider as well as one motion to consider. A tally will be conducted at the end of May, so the elected candidates have time to make arrangements to be present at the 2025 Annual Summer Meeting.

The awards, medallions and plaques have been ordered to be presented during the Regional Assembly. Also, Bob and I are still working on the board gift.

Last but not least, I want to thank the AANR-East Officers and Board of Directors for allowing me to serve the association for 24 years as the Secretary/Treasurer. It has been a pleasure and I hope that they will allow me to continue in that capacity.

AANR EAST REGIONAL TRUSTEE REPORT Sandra Cordell

I attended the mid-winter meeting of AANR-East at White Tail Resort in Ivor, VA in January 2025. It was a good meeting with continued emphasis on how to get more clubs active within AANR and what we can do to assist the clubs with anything that may be issues for them and their AANR members. I was online a few times along with over 250 others, both AANR members and non-members. I have to say it is interesting to chat with others about whatever comes up in discussions. There were three motions that the Board had considered since our Interim Board Meeting. Motions 1 & 2 were made by Maker, Leo Blake, second, Judy Turner. Motion #3 was made by the Legislation Committee.

- **Motion 1.** Move to add the following to the procedure manual under section 6.00.01 Governance KRA Director.
 - f. Club Liaison is expected to:
 - a. Contact each of their assigned clubs during their seasonal/annual hours of operation as frequently as necessary.
 - b. Inform clubs of AANR-East and AANR issues and priorities for the current year.
 - c. Seek information regarding membership interests and concerns regarding the AANR-East and AANR.
 - d. Report monthly to the AANR-East Liaison coordinator on liaison activities.

PURPOSE: To create club liaison duties and responsibilities. **FISCAL IMPACT** (if any): None Passed Unanimously

Motion 2. Move to add the following to the procedure manual under section 9.04.03:

 f. The AANR-East shall reimburse each authorized liaison person for verified liaison expenses, with a maximum limit equivalent to \$100 per assigned club annually. Prior approval of the president and liaison coordinator must be received and submission of an authorized AANR-East Voucher.

PURPOSE: Establish reimbursement for club liaisons. **FISCAL IMPACT** (if any): \$100-\$1800 Passed Unanimously

Motion 3. Move to add the following wording to 2 sections of Form #35 of the Procedure Manual Appendix as follows:

ELIGIBILITY

4. If an applicant does not have any of the above mentioned recreational vehicles or tenting equipment, they may make reservations for lodging at the host club, but reimbursement will not exceed the host club normal full hookup charge.

REIMBURSEMENT

2. Camping/grounds fees at a landed club with receipt. If visiting a non-landed club, overnight fees are not included. Room rental at a landed club is not included but reimbursement will not exceed host club's normal full hookup charge.

PURPOSE: To allow individuals that do not have their own RVs or tenting equipment to still apply as Roving Ambassadors but restrict reimbursement amount. **FISCAL IMPACT** (if any): Unknown Passed Unanimously
